All Float and Car Entries: All float and car entries must be decorated in accordance with the theme. Any car entries not decorated will not be able to participate except for classic and antique cars. We require that all floats be decorated and have some type of music to play throughout the parade route.

Notice to all participants: Throwing anything heavy is prohibited from the entrants. No throwing of candy or any objects. Paper handouts are prohibited. The line-up will be in accordance with protocol and at the discretion of the parade committee. Any animal entries must be accompanied with a pooper-scooper and will be required to pick up any feces after animals.

**Liability:** Kiwanis Club of Pahrump, its Parade Board, and its staff will not be responsible for losses of any kind, whether by fire, theft, physical violence, elements of nature of any other cause, however originating.
